

## Instructions for Authors

‘‘Séminaire Mathématiques de Béjaïa (LaMOS)’’ is an open access journal, free of charge, specialized in applied mathematics. Founded in 2002, it is published once a year by the Research Unit (LaMOS), Faculty of exact sciences, Bejaia University (Algeria).

### Manuscript Submission

Submission of a manuscript implies that the work described has not been published before; that it is not under consideration for publication anywhere else; that its publication has been approved by all co-authors, if any, as well as by the responsible authorities - tacitly or explicitly - at the institute where the work has been carried out. The publisher will not be held legally responsible should there be any claims for compensation.

### Permissions

Authors wishing to include figures, tables, or text passages that have already been published elsewhere are required to obtain permission from the copyright owner(s) for both the print and online format and to include evidence that such permission has been granted when submitting their papers. Any material received without such evidence will be assumed to originate from the authors.

### Funding

All the funding sources should be listed in the acknowledgement section. The authors are responsible for the accuracy of their funder designation.

### Online Submission

Authors should submit their manuscripts online. Registration and login are required for submitting items online, and for checking the status of current submissions. Electronic submission substantially reduces the editorial processing and reviewing times and shortens overall publication times. Please follow the hyperlink [Submit Online](#) and upload all of your manuscript files following the instructions given on the screen. The papers, not meetings the Journal's requirements will not be considered.

## **Main text file**

Manuscript must be uploaded as a single document (containing the main text, figures and tables) according to the journal template.

The main text file should include:

- Title page.
- Abstract.
- Keywords.
- Main body.
- Acknowledgement.
- References.

## **Title Page**

Please make sure your title page contains the following information.

### **Title**

The title should be concise and informative. The title should not contain abbreviations.

### **Author information**

- The name(s) of the author(s)
- The affiliation(s) and address(es) of the author(s)
- The e-mail addresses author(s)

## **Abstract**

Please provide a structured abstract of 50 to 150 words, which should be divided into the following sections:

- Purpose (stating the main purposes and research question)
- Methods
- Results
- Conclusion

Abstract should not contain any citation to any other published work.

## **Keywords**

List of 4-6 key words must be given. When choosing consider search engine optimization to make your article more visible once published.

## AMS Subject Classification

The author(s) should provide AMS Subject Classification numbers using the link

## TEXT

### Text Formatting

Manuscripts should be submitted in LaTeX.

The submission should include the original source (including all style files and figures) and a PDF version of the compiled output.

### Abbreviations

Abbreviations should be defined at first mention and used consistently thereafter.

## REFERENCES

### Citation

Reference citations in the text should be identified by numbers in square brackets.

### Reference list

The list of references should only include works that are cited in the text and that have been published or accepted for publication.

The entries in the list should be numbered consecutively.

## **TABLES**

- ✓ All tables are to be numbered using Arabic numerals.
- ✓ Tables should always be cited in text in consecutive numerical order.
- ✓ For each table, please supply a table caption (title) explaining the components of the table.
- ✓ Identify any previously published material by giving the original source in the form of a reference at the end of the table caption.

## **FIGURE NUMBERING**

- All figures are to be numbered using Arabic numerals.
- Figures should always be cited in text in consecutive numerical order.
- Figure parts should be denoted by lowercase letters (a, b, c, etc.).

- The absolute minimum for acceptable resolution is 300 dpi, though higher is preferable, sized to fit a journal page, and in EPS, TIFF or JPEG format.
- Each figure should have a concise caption describing accurately what the figure depicts. Include the captions in the text file of the manuscript, not in the figure file.

## **PEER REVIEW**

This journal follows a single blind peer review process. Papers will only be sent to review if the editor determines that the paper meets the standards of the journal. Papers are then sent to a minimum of two (02) independent reviewers to assess the scientific quality of the papers. The editor is responsible for the final decision regarding acceptance or rejection of the paper.

## **OPEN ACCESS POLICY**

All published articles in SMB ‘‘Séminaire Mathématiques de Béjaia (LaMOS)’’ are immediately available worldwide under an open access license. This means that the corresponding author certify:

Authors will be asked to transfer copyright of the article to the Publisher (or grant the Publisher exclusive publication and dissemination rights). This will ensure the widest possible protection and dissemination of information under copyright laws.

## **PROOF READING**

The purpose of the proof is to check for typesetting or conversion errors and the completeness and accuracy of the text, tables and figures. Substantial changes in content, e.g., new results, corrected values, title and authorship, are not allowed without the approval of the Editor. After online publication, further changes can only be made in the form of an Erratum, which will be hyperlinked to the article.
