workplaces for a long time, which created a kind of hardship for the individual and repression Social and psychological, as well as widening the scope for some criminals to commit multiple crimes, especially the crime of exploitation resulting from the urgent need for medicines, drug alternatives, and masks, as well as crimes related to fraud, fraud, theft, vandalism, and other crimes. Introduction

Crime has been known since ancient times and since the beginning of creation, when Cain killed his brother Abel. Can you imagine the development of something from ancient times to our present time?!! A great and vast development indeed...just as everything around us has evolved.....socrime is developing...the current criminal studies criminology and steals using the computer and is looking for all new means that allow him to commit his crime with the least possible harm to him and that will reduce the chance of Catch him.

1. The problem of the study:

The Corona epidemic period is a different period at all levels, and in terms of crimes, some crimes declined compared to other crimes due to quarantine conditions and general health conditions. General organized crime and its activities at the beginning and then the crime tried to adapt to reality and exploit opportunities, and this leads us to pose the following problem: What is the relationship between the period of the Corona virus and the increase in the rates of some crimes?.

2. the crime

2.1 The Concept of Crime

It is necessary to define the crime in itself, and with reference to most of the national legislation, it does not set a definition of the crime, but is limited to clarifying its elements, leaving the matter of defining it to jurisprudence. Among its definitions are the following: "A crime is every act or omission to do an illegal act that is prohibited by law and for which a penalty is determined in the form of a penalty or a punitive measure as stipulated in the Penal Code."

Jurisprudential Definition of Organized Crime

Dr. Muhammad Farouk Al-Nabhan defines organized crime as "that crime that was produced by material civilization in order to enable the criminal person to achieve his criminal goals in an advanced way that the law is unable to pursue thanks to the means that surrounds himself by which he hides his criminal purposes, and to achieve this goal it is necessary to cooperate with a group of criminals صفحة (1960). (2

Dr. Mostafa Taher defined it by saying: "Organized crime is a diverse and complex crime of criminal activities and rapid, largescale operations related to many illegal goods and services dominated by very powerful and organized gangs, which include thousands of criminals of different nationalities, and are carried out with a great deal of professionalism, continuity and the strength of oppression, and aims to achieve financial profit, gain power and influence using many different methods.



Definition of the 2000 United Nations Organized Crime Convention

The United Nations Convention against Transnational Organized Crime, held in Palermo, Italy, in the year 2000.Organized crime was defined in terms of criminal organization, as it was stated in paragraph 2.

(a) the following: "The expression of an organized criminal group means a structured group of three or more persons existing for a period of time and acting in concert with the aim of committing one or serious crimes and offenses more established accordance with this in Convention, and in order to obtain directly or indirectly to a financial or other material benefit."

As for paragraph -b, it states: "The expression of a serious crime means conduct that constitutes a crime punishable by complete deprivation of liberty for a period of no less than four years or a more severe penalty."

What is noticed on the definition is that it focused on the criminal organization that engages in criminal activities, so that the definition referred to all the elements of the organization represented in continuity, and the pursuit of financial profit by committing serious crimes. Its sentence is not less than four years.

On the other hand, the International Criminal Police Organization defined it in the first international symposium held in Saint-Claude, France in 1988, which was devoted to the topic of organized crime. Its primary motive is to obtain profits without regard to the national borders. Finally, we conclude that organized crime is a criminal institution with a gradual and tight structural organization that engages in illegal activities in order to obtain an illegal material goal, or prejudice the strategic interests and public security of a country or a number of countries, using violence and force in that And corruption(93 صفحة 2006، صفحة 2006).

2.2.The Characteristics of Organized Crime

Organized crime is one of the serious crimes, and it is the biggest challenge facing the international community, and its danger emerges through the organization and planning that ensures its success and continuity so that it is difficult to cordon off and eliminate it easily, because the criminal organizations that prepare for organized crime are mostly the owners of Expertise and professionalism who plan for that crime in a controlled manner that ensures success in its implementation, and there is almost agreement about the characteristics of organized crime among specialists in the legal field, the most important of which are the following:

Planning:

It is considered the most important feature in organized crime. Crime that is committed without planning does not fall within the scope of organized crime, and planning is not an easy process. It requires a class of professionals who have personal

qualifications, experience and knowledge that enable them to bridge all legal and economic gaps that can lead to discover the crime before it is committed and during its execution.

Organization:

The conduct of organized crime requires the existence of a highly organized criminal organization in order to be able to say that it is committed, and this was indicated by the United Nations Convention against Transnational Organized Crime, held in Palermo in 2000, where it indicated that "a group with an organizational structure means a group that is not formed randomly." for a purpose

The immediate commission of a crime and its members do not need to have formally defined roles and their membership in them should continue."

Complexity and Secrecy

Complexity and secrecy are one of the conditions for committing organized crime, so that they are so complex and difficult to detect them. Complex crimes are often resorted to because they find fertile fields for the application of different methods that achieve transgression of the law, and for this reason the criminals are hidden from many of those who participate with them. The action is because the angle of deviation is not clear, therefore the criminals escape punishment, because in that they hide their illegal behavior by actions that appear on their surface to be legitimate actions.

Professionalism and Continuity

Practicing criminal activity requires a type of qualification that is not available to everyone because the majority of people do not accept the risk of perpetrating organized crime due to religious, ethical and social considerations. Therefore, whoever works within the framework of organized crime and accepts the risk needs to be professional.

The Ability to Hire and Blackmail

This characteristic is related to the nature of organized crimes, because the criminal can only do his work by harnessing the elements to enable him to do what he wants, and he uses all possible means to subjugate other individuals in exchange for services or material or moral interests, and certainly, the most important of these capabilities is money. Moreover, we find that the process of recruiting individuals into criminal organizations is not random, but is always smart. Not everyone is fit to join this organization. Criminals are often smart in choosing the people who deal with them directly or indirectly. They are able to extend their authority over those, Blackmail even physically liquidate them. and them(131، صفحة 1992).

Society's Coexistence with the Phenomenon of Crime

This characteristic is considered one of the most dangerous characteristics of crime, because when crime can penetrate into the circles of society, it becomes a familiar behavior to which people are subject. Man always tends to be calm and stable and keep away from dangers, and when individuals feel or feel that crime is dominant within society, they surrender and they are forced to coexist with the state of criminality and cooperate with criminal organizations for fear of it, so that the commission of crimes through organized crime undoubtedly aims at illegal acts, but to camouflage these activities are mixed with legitimate activities and thus try to integrate their illegal activities into legitimate companies or try to give the character of legality of those activities, and thus the illegal activities are integrated into the social entity.

Outrageous Financial Profit

Organized crime mainly aims to achieve profit as a goal along with other goals (such as political ones), and it is said that the huge profits it achieves at the level of countries are invaluable (نزیه، دت، صفحة) (3.

3. Covid 19 (Corona Virus)

3.1 The Definition of the Corona Virus

Corona viruses are a large family of viruses that cause diseases in both humans and animals.

It is known that the emerging of corona affects the respiratory system in addition to

other more serious diseases such as Middle East Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS).

Recently, a new type of corona virus appeared and caused the death of many around the world, and it is still continuing until now.

"Covid-19" is the name of the contagious epidemic caused by the emerging corona, the virus first appeared in December 2019 in the Chinese city of Wuhan, and the disease was identified on January 13, following symptoms that appeared on a group of patients.

The epidemic first appeared in a market for seafood and animals, and then moved from it to the rest of the cities of Hubei Province, and from there to the provinces of China and then to the rest of the world.

3.2. Statistics of the Development of Crime for the Year 2019 Compared to the Year 2020

The interests of the National Gendarmerie recorded a significant increase in criminal cases of all kinds, as well as trafficking and consumption of narcotics and psychotropic substances in 2020. This period also witnessed an increase in attacks against property, thefts and the formation of associations of villains, as the National Gendarmerie units, since August, put an end to the activity of 46 neighborhoods gangs consisting of 255 people involved. The outcome of the activity of the National Gendarmerie for the year 2020, revealed an increase in the crime rate and the number of arrested persons, as indicated by the presented ,yesterday, by numbers that Marroush, Head of the Colonel Mounir Judicial Police Department, Lt. Colonel

Abdel Karim Rabiei, Head of the Roads Security Department, and Lt. Colonel LounisMeli, Head of the Department of Prevention and Public Security in a press conference held at the headquarters of the General Command of the Gendarmerie in Cheraga, the capital ,which included the outcome of the gendarmerie interests of the last year that knew the application of quarantine procedures to confront the Corona pandemic. In this regard, Colonel Marroush explained that the activity of wicked associations increased by 21% in 2020, which recorded 743 dismantled associations, compared to 2019, during which 614 evil groups were recorded and their activities were put to an end. The number of arrested persons also increased by 34%, and organized crime recorded 3% of the total number of criminal acts, where drugs came at the top of the ranking with 6611 crimes. This means 39%, followed by smuggling with 3,716 crimes. which means 22%, and possession of weapons and ammunition with 20%, and acts related to illegal immigration by 19%.

The same interests provided details of drug-related cases, criminal acts and those involved in them, as an upward trend was recorded, both for criminal acts, which rose by 38%, or for those involved, whose number increased by 35% compared to 2019, while more than 62 tons of treated quality were seized. More than 11 kg of Cocaine and 114 Cannabis Bushes. A rise in materials, smuggling of various fuel. livestock and others has also been registered. The phenomenon of property especially thefts, abuse. witnessed a significant increase, as 14,849 cases of theft, 5,402 cases of vandalism and destruction of infringement on real estate property, 2028 cases of burglary, 201 cases of concealment of things and 20 cases of infringement of intellectual property, and criminal acts increased by 5% compared to 2019, while the number of detainees in connection with these cases increased by 20%. The same outcome revealed that during the quarantine period, more than 16,000 gendarmes were recruited as part of the daily tasks associated with imposing quarantine procedures and 5,894 gendarmes were recruited to secure quarantine sites for Algerian nationals coming from abroad, 49,932 awareness campaigns were organized, and 18,923 sterilization and disinfection campaigns were organized, with the harnessing of 2155 means to carry out disinfection operations. As for the violations that were recorded during the pandemic period, a total of 91,897 violations of quarantine measures were counted, resulting in the placing of 25,527 vehicles and motorcycles in Al-Mahshar, and 10779 violations related to speculation. monopoly and fraud in commercial practices, which resulted in the arrest of 19,338 people, and the seizure of 9,400 tons of foodstuffs, 57,755 units of pharmaceutical materials and 61,877 units of sterilization solutions. On the other hand, the interests of the National Gendarmerie recorded a significant decrease in traffic accidents in 2020, and the wounded and dead compared to 2019, noting that these results show the embodiment of the goal set by the National Gendarmerie leadership of reducing the number of accidents and victims, as procedures were tightened and the penalty was doubled for the owners of heavy-weight vehicles and buses in which





the toll is heavy, as traffic accidents are still concentrated in the central region, which witnesses traffic, the states of M'sila and Setif recorded the highest number of deaths in traffic accidents in 2020. (statistique, 29 août 2021).

3.3.Examples of some of the increasing crimes during the Corona virus period:

1. **Theft** of closed mosques:The psychological state of Muslims was greatly affected after the decisions to close places of worship in most countries of the world as a precautionary measure to prevent the spread of the virus. But there are those who find an opportunity in closing and preventing prayer. Some thieves took the opportunity to close mosques "due to the outbreak of the virus, and stole parts of equipment from mosques. The schemes of thieves who benefited from the outbreak of the virus are not limited to stealing places of worship, but extend to stealing what can be stolen in light of the police's preoccupation with activating the ban procedures and punishing those who hack it." Like railroad robbery.

2. Other tons of adulterated masks: but of fabrics and threads, were found in a clothing factory in the governorate of Kafr El-Sheikh (Northern Egypt), which the factory owner uses to manufacture medical masks that do not comply with standards and specifications, are not licensed and are not sterile, and are packaged in packages bearing fake names and trademarks, to take advantage of The historical demand for the purchase of masks and their surprisingly high prices in the markets. which are witnessing many accidents that are being managed and implemented as a result of Corona. It is hiding goods to thirst the market, then relaunching them at exaggerated prices, or offering expired food commodities depending on the buyers' demand to purchase the existing without checking in light of the limited shopping hours and the scarcity of some commodities in the markets. And not a day passes without dozens of merchants who hide goods and exaggerate the second prices and put out a third that has expired, whether in their stores or through goods delivered through the home delivery service, which have other purposes in the time of Corona.

3. Delivering drugs to homes: The International Criminal Police Organization "Interpol" issued a strong warning a few days ago against the use of food delivery services by criminal organizations, whose frequency has escalated all over the world due to citizens staying in their homes, to transport drugs and other prohibited materials and goods. Interpol had received several police reports from Ireland, Malaysia, Spain and Britain stating that the delivery service was not limited to transporting food commodities and household necessities, but that some used it to deliver narcotic substances such as cocaine, marijuana, ketamine and ecstasy. It is noteworthy that in early April, the Spanish police arrested seven people dressed as delivery workers in Alicante and Valencia on charges of delivering cocaine and marijuana to motorbikes and cars intended for delivery services. In Ireland, police found firearms and cocaine hidden at the bottom of pizza boxes delivered by delivery workers. The "Interpol" notes that the closures worldwide, have led to a staggering increase in the demand for food delivery service home. The sight of delivery drivers on their motorcycles, bicycles or cars became common on deserted streets.

4. Advanced technical frauds: The changing crime patterns due to Corona

and the emerging threats due to the many unconventional procedures followed have led to many unconventional efforts also to track these patterns to confront them and perhaps predict them to prevent them before they occur. For example, the Institute established the "Corona Fraud" or "Corona Scam" website in late March for Combating Economic Crime of the University of Arts and Applied Sciences in Switzerland. The site monitored hundreds of scams that use advanced techniques carried out by highly intelligent criminals over the Internet. Most of the cases are done by advertising fake goods, as browsers request them and provide sites with their bank account details and secret numbers, and then the goods and sites evaporate into the air. And the absolute majority of these fake goods are masks, disinfectants and detergents. Other sites actually send the requested goods, but it turns out after receiving them that they do not conform to the specifications, or bear fraudulent trademarks. Fraud and fraud of another kind monitored by the site, which is the claim of some on the Internet that thev are collecting donations for international organizations working to confront Corona and support the most affected countries and the most vulnerable health systems around the world, or interactive map sites that show the rhythm and rates of spread of the virus and ask for donations as well, and donations settle which are paid electronically into the pockets of fraudsters.

5. The crime of intentionally infection with the Corona virus: Diseases that spread through infection are known. This type of crime in which the person is known to have

contracted the disease, yet he seeks to be in the places where people are present or to have sexual relations and others.. To transmit viruses and the Corona virus is characterized by the feature of transmission quickly and many individuals have deliberately intended to transmit the infection to others, whether directly or indirectly, during the period of quarantine in many countries, including Algeria and it has had serious consequences that are not limited to the number.

Since the law adapted it on the basis of premeditated murder and on the basis of poisoning or conditioning on the basis of intentional harm, Hussein Ahmed says in his criminal article responsibility for transmission of infection with the Corona virus (Covid-19): "And by analyzing all find that these possibilities, we the description of premeditated murder in The case of transmission of infection with the Corona virus is encountered by some difficulties. due to the delay in the occurrence of the result for a period of time and may not lead to the result of death ... ", despite that, the legislator criminalizes this act in the event of intent (أحمد، 2020، صفحة) .(496

4. Factors that led to the growth of crime in light of the Corona virus:

Exploitation of human fears and anxiety. Expansion of remote work.

The difficulty of securing an electronic business environment.

Increasing reliance on social media applications.

Increasing the period of using the Internet, which exposed a number of risks and crimes, especially crimes of exploitation(2020 (خليفة).



The high prices of most basic materials, which resulted in material need.

High demand for some commodities, protective equipment and pharmaceutical products.

Financial need due to the closure of most commercial activities.

The lack of general societal control, which reduced social control.

Psychological problems resulting from psychological depression.

Family problems due to frequent friction and constant stay at home

Online shopping in light of the closure of major stores .

Moving to work and education online.

Increased fear and anxiety that creates susceptibility to fraud.

4.1. Psychological effects of quarantine:

The Lancet Medical Journal published a review of 24 studies documenting the psychological impact of a quarantine, and according to a report published by the magazine under the title The psychological impact of quarantine and how to reduce it, research confirms the devastating and negative psychological effects, including symptoms of post-traumatic stress and confusion. And anger towards home isolation, stresses intensify the longer the quarantine period, fears of infection, frustration, boredom, insufficient supplies and financial loss. Research for this magazine also indicates that in cases where parents are isolated with children, at least 28 percent Those isolated suffer from PTSD, and about 10 percent of isolated hospital staff have been found to have severe depressive symptoms.

This is because a person is by nature unable to bear such restrictions, especially if he met with an unknown period and a dangerous health condition, and thus he is under great psychological pressure and challenge, because freedom and a sense of security are among his basic needs.

Those in quarantine suffer from boredom, anger, psychological loneliness and despair (Xiange et al, 2020) and one of the most important reasons for fear of the Corona pandemic is exposure to pressure through the news that an individual hears every day about injuries and deaths in the media, and this is accompanied by symptoms such as feelings of fear and terror. And others, which made individuals avoid each other (Lei, L.; Huang, X.; , Zhang, S., Yang, J., &; Yang, L., 2020).

(Huang, Y. & Zhao, N., 2020)found in a study on symptoms of anxiety, depression and sleep disorders among 7235 Chinese, that general anxiety spread by 35.1%, and depressive symptoms spread by 20.1%, while sleep disorders amounted to 18.2% among sample members.

In a study conducted in China on 1593 individuals by (Lei & al, 2020), the prevalence of anxiety was 8.3%, while depression was 14.6%. The study also made a comparison between those who were affected by the stone and those who were not affected, as symptoms of anxiety and depression spread among those who were affected by the stone (22.4%, 12.9%), respectively, and those who were not affected by it were (11.9%, 6.7%).

In another study conducted on 1556 Italians during the quarantine period, (Altena, E.; B, et al., 2020) it was found that anxiety symptoms spread by 24.7%, and the prevalence of anxiety disorder was

(23.2%, while 42% of the sample members suffered from sleep disorders). **4.2 Social effects of quarantine** وردة، (2021):

Each of them believes that "not all families are in the same level of luxury or need." Some families practice stone in a palace or a luxurious estate, and some are trapped inside a hut or a house made of tin or fragile construction, and some of them live in the city and have access to goods or The commodity is available in major markets that respect the price law, including those who live in popular neighborhoods or rural areas, and the possibility of their access to the commodity, even if it is available, is uncertain, and even if it is confirmed in reality, there is a pocket void between it and the absence of purchasing power, and therefore it is expected that social life will not return to its levels. Before the pandemic for very wide social segments, which is likely to turn these families into poor and destitute projects and social hotspots in the face of capitalist policies." In studies around the world, the result was that most people developed a state of social phobia upon hearing the news of the expansion of the disease pandemic. (44.9%) have indicated that they are exposed to family problems, most of which are problems that children face with their parents as a result of staying at home, and that all individuals have suffered financial and social damages and costs as a result of staying at home to prevent corona virus, whether Through anxiety, fear or leaving work, unemployment and poverty. Whereas, in light of the Corona crisis, the work of the head of the family has become from home. and the lessons of the children are all via the Internet, and each family member continues to carry out all his activities without leaving the house, which led to an increase in interaction and friction with family members, which is considered one of the positive things in general. General, but with the length of the quarantine period and the increase in leisure time, in addition to the instability of the financial situation and concern about contracting the disease. The psychological pressure and tension that caused some family problems increased. Also, the loss of the usual daily behaviors and the reduction of contact and friction between members of the community leads to a feeling of boredom, frustration and anxiety.

The effects were generally summarized (71/64، صفحة 2020، صفحة 2021)

In the following:

Isolation of children.

fathers and mothers in the role of teachers.

Some families do not have computers or the Internet in their homes.

Lack of proper nutrition.

Academic delay and lack of socialization.

5. Analyzing statistics according to the theory of life stressors (hardship):

Scientists are intensively interested in the impact of life stresses on an individual through his life or through the environment in which he lives, in relation to anti-social behavior in general and criminal deviant behavior in particular. This theory is based on the assumption Life stresses act as external stimuli that affect some psychological processes that push a person to aggressive or violent behavior, and in light of this general hypothesis, this theory





tends to emphasize two types of pressures, stimuli, or hardship(2011 (معتوق).

The first type: It is related to unpleasant events and stresses at work and various roles as triggers of hardship that produce violent, criminal or aggressive behavior.

The second type: related to environmental pressures represented by noise, congestion and pollution, in addition to other pressures such as breaching individual borders and assaulting personal space...etc.

And the theory of hardship explains the pressures that the individual was subjected to during the epidemic, which made these pressures froth out of the crime rate in society, especially with the state of alert that he suffered from, as well as the problem of speculation in prices and goods. Because the spread of the Corona virus led to an impact on individual and social behavior, as organized groups adapted to the variables and exploited and employed the crisis to achieve their goals, continuity, and even an increase in the rate of criminal domestic violence crimes behavior, as escalated and increased in severity, as aggressive behavior prevailed in homes, as well as assault crimes. On the medical staff. as individuals are spending large periods at home with pressure and a lot of free time, this has led to a lot of conflict between members of the same family with problems of securing the necessary necessities. During the epidemic, the demand for economic activity via the Internet increased, which made many vulnerable to electronic fraud

and looting, as well as the sexual exploitation of children on the Internet.

Economic factors have been considered as motive for crime on the basis that economic deprivation leads to the commission of crime. Sociologists have indicated that crime mainly stems from the inefficiency of economic and social conditions that affect the personality of the individual and push him to commit crime directly or indirectly, and that the weak economic environment and the growth of Unemployment and the increasing rates of devastation and the destruction of things and property are responsible for the high crime rates. As most research has shown that poverty is the main cause of crime, in addition to the general conditions, especially the lack of education and its quality, deprives individuals of satisfying their needs and prepares them to fall into crime and links the sects between economic factors And crime. The contingent factors were also considered as motivators of crime on the basis that the turbulent social environment and the state of alert in the case of the Corona epidemic, with its many elements, push the individual to crime and lead to poor acquisition of social standards and lead to an aggressive personality lacking self-control, which increases hatred for society. And family problems lead to family problems. Resulting from the vacuum and the frequent friction associated with the quarantine, the deviation of the Behavior where a large percentage of these families found that emotional relationships were disturbed before and after actual or unreal family disintegration.



6. CONCLUSION

There is no doubt that crime constitutes a social danger because it is considered a violation of rights or interests worthy of criminal protection, and it threatens the human entity in its security, stability, and even life.

The Corona epidemic period has shown new crimes and increased the severity of other crimes, especially electronic crimes and cyber crimes, due to the excessive use of the latter, with or without a need.

The hardship resulting from the pressures of daily life during the quarantine period, especially and the epidemic period each year, contributed to the emergence of some violent, criminal or deviant reactions in general as a result of social exclusion factors and the emergence of social classes that were unable to cope with this period in all material, psychological and social aspects...
