



3) DUTIES OF AUTHORS

Manuscripts are to be edited in accordance with the submission guidelines the review. Authors are also responsible for language editing before submitting the article. Underlying data should be represented accurately in the paper. A paper should contain sufficient detail and references to permit others to replicate the work. Fraudulent or knowingly inaccurate statements constitute unethical behaviour and are unacceptable.

- Originality and plagiarism: The authors should ensure that they have written entirely original works, and that the work and/or words of others have been appropriately cited or quoted if the authors have used them.
