Review Publication Rules:

✍ The Review of “El Moufakir” is a scientific review which deals with subjects related to Law and Political Science only.

✍ The submitted article must be a pure research, and has not been published before in any way.

✍ The article must be written with Microsoft Word (Sakkal Type, size 12; for Arabic, and Times New Roman, size 11 for foreign languages). For titles, must be written with 14 size with the same type but in bold). It must be taken into consideration in the size of the article; 25 pages as a maximum of 4A (16x 23.5 cm) including the references, tables and illustrations, pages must be numbered sequentially.

✍ The first paper must contain the full title of the article with a translated version of English, the name of the researcher and the scientific grade, the institution (department, college and university), e-mail address, and two abstracts of the subject within 200 words or eight lines, one in the language of the article and the second in one of the other two languages, in condition that one of the two abstracts must be in Arabic, in addition to the key words.

✍ References list: the references must be listed in the end of the article, using American Psychological Association (APA). <https://www.youtube.com/watch?v=AmiKbIUOs 8A>), by mentioning (the author, the year, page) in the heart of the text (Brown, 2006, p35). The reference must be fully mentioned in the end of the article.

✍ The articles submitted are subject to confidential scientific arbitration, and will not be given back to their owners; whether were published or not.
