- The Algerian Review of Ottoman and Mediterranean Studies is a biannual Journal published by the Laboratory of Studies and Research of Ottoman Heritage in Algeria, University of Algiers 2, Algerian Republic. Founded in 2021, it aims to be a support for the history of the Ottoman world and the regions that belonged to it, including *al-Jazâ'ir*, during the modern period in particular.

- The Algerian Review of Ottoman and Mediterranean Studies contains unpublished historical scientific studies in the field of Ottoman and Mediterranean history, and seeks to produce a highquality scientific papers of specialized researchers who will exchange views to promote scientific research.

- The Review gives priority to studies on the history of political and cultural relations, economic exchange in the Mediterranean basin, the history of migration, the phenomenon of travel, within the Ottoman world as well as between the latter and the outside world, in the bilateral, regional and global landscape.

- The Algerian Review of Ottoman and Mediterranean Studies seeks to focus on historical studies, leaving the field of research open to the interaction between history and other humanities and social sciences.

\* Author's Guide: This file contains: author's guide, the Review publishing charter, copyright transfer document. Consult these files for various manuscript preparations.

\* Author's Instructions: Contains an article writing form in the the languages in which the Review is published. Choose the right form for the language of your article.

### -Preparing the manuscript

\* Articles must be in Sakkal Majalla script 14 font size and simple spacing; the rest of the details are in the form.

\* Ethically, you are solely responsible for your article and its contents, see the Review's Publishing Ethics Charter.

\* Your contribution to the Review can be in different forms: an article summarizing theoretical scientific research; a report on a scientific event; or a presentation of a recently published book.

\* The Review accepts only original articles for evaluation that correspond to the Review's form that you have previously downloaded. Once the article is accepted for publication, the article becomes the property of the publications of the University of Algiers2, Algeria, and cannot be republished; see the copyright transfer document.

\* The editorial team reserves the right to modify the final version of the research, if necessary, to be more compatible with the Review's template.

\* It is very important to note that the author is obliged to write his text in a simple way and avoid special formats. The editorial team will be responsible for coordinating all articles of the issue, so all formats that do not conform to the template of the Review will be removed. \* The size of the text should not exceed 6000 words (not including the bibliographic list).

- After the article has been adapted to the Review's publication terms, check it in the Review's article form.

- Be sure to respect all the settings you'll find in the article form. Then, save all the modifications you have made, and write your name in latin letters.

# -Submitting the article

\* Articles are sent to the Review by email at: aroms@univalger2.dz

# - Acceptance of the article for evaluation and publication

\* When the article is received, the editorial board check the author's respect for the requirements of the article form, and the authenticity of the article. Only when the two evaluations are positive is the article accepted for evaluation.

\* The article is saved and encoded in PDF format so that the name, surname, and other identifying information are concealed.

\* The article is sent to the associate editor specialized in the subject matter of the article.

\* The associate editor sends the article to two reviewers; each article submitted to the Review is classified (the reviewers do not know the name of the author of the article, nor does the author know the identity of the reviewers). Peer-reviewing allows a careful and objective evaluation by specialists.

\* After the review is completed, the associate editor may, based on the reviewers' reports, reject the article, accept it as it is, or accept it with reservations.

\* In case of acceptance with reservation, the article will be returned to you. Check the reviewers' reports, remove the reservations, send the article back, by providing explanations and clarifications to the reviewers.

# - Transmission of acknowledgment of copyright transfer

\* Upon approval of the publication of the article, the author sends a (scanned) pledge to transfer copyright in the form of PDF/Image (form available on the above link) to the editor-in-chief via e-mail to the Review at: aroms@univ-alger2.dz. At this stage, the author can request a promise for publication if necessary.

#### Presentation

In this first issue of the review, seven articles in Arabic, Turkish, French or Spanish, deal with the history of relations between the shores of the Mediterranean as well as the Saharan confines of the Ottoman Empire. Mr Gerard Van Krieken even deals with the little known activities of Algerian privateers in the North Sea. His article, drawing on both Dutch and French archives, is a definite contribution to the knowledge of Algerian privateering activity in the 17<sup>th</sup> century and sheds light on the subtleties of Al-Jazâ'ir's political relations with foreign powers. Ms. Yamna Behiri uses manuscripts from the National Library of Algeria to describe the rules governing the garrison of the janissaries of Biskra, on the Saharan borders of Algeria, at the end of the Ottoman era. Thus, we know more about the functioning of the nuba and the relations of the janissaries with the populations of the interior of the country. Mr Gennaro Varriale evokes the tribulations of the late Hafsid dynasty. in the context of the Ottoman-Habsburg confrontation in the Mediterranean, and the path of exile towards the Italian peninsula and Sicily, which some members of this dynasty experienced in the service of the Habsburgs. Mr Varriale has relied in particular on the Spanish archives of Simancas, but also on some documents from the Italian archives. Mr Amine Mahrez drew an interesting parallel between the Phoenician Cothon of Ikosim and the arsenal of Khayr al-Dîn Barbarossa in Algiers, built about two thousand years later, and this study echoes the excavations recently carried out at the Place des Martyrs. El Cheikh Lekhal used documents from the Ottoman archives in Istanbul to study the situation of the Châamba on the borders between Ottoman Libya and French-occupied Algeria at the beginning of the 20<sup>th</sup> century. This study reveals that the resistance of the Châamba tribes against the colonial France took place without any allegiance to the Ottomans and without their support. Ms. Yasemin Nemlioğlu Koca highlights through the press documents of the Donanma Mecmuasi, or Ottoman Navy Magazine, published between 1910 and 1918, the Maghreb policy of the Ottoman Empire during the nineteenth and twentieth centuries and, in particular, the use during the First World War, of the Islamic rhetoric of Jihâd in the struggle against the enemies of the empire, including France. Finally, in the multidisciplinary spirit of the

journal, Ms. Serpil Ersöz proposed an enlightening comparative study, in terms of anthropology, of the concept of friendship in Turkish and Algerian cultures through proverbs.
