Author's guide

1- Presentation of the magazine:

AL-BASAER JOURNAL OF ECONOMICS, COMMERCIAL AND MANAGEMENT SCIENCES RESEARSH is an international, double-blind, peer-reviewed, bi-annual, and free-of-charge open-access journal published by the Institute of Economic, Commercial, and Management Sciences at the University Center of Tipaza.

The journal focuses on publishing original research that is presented accurately and objectively, following the scientific approach expected of refereed journals. It covers the field of economic, commercial, and management sciences and accepts submissions in Arabic, French, and English. The journal's primary areas of interest revolve around three axes: food security, health security, and energy security.

2- Objectives of the journal:

The main objectives of this journal are as follows:

- Actively participating in enriching scientific research in the fields of economic, commercial, and management sciences.
- Encouraging scientific research and staying up-to-date with developments in the respective fields.
- Providing a platform for publishing original scientific research in the areas of economic, commercial, and management sciences.
- Supporting researchers in this field by offering a comprehensive reference that includes accurately and objectively presented original refereed scientific research.
- Aspiring to become a leading scientific destination and to be included among the journals classified in international databases in the future.

3- Articles submission procedures:

- We invite researchers who wish to publish their articles to carefully review the 'Instructions for Authors' and 'Guide to Authors' available on the journal's page on the Algerian scientific journals platform ASJP: <https://www.asjp.cerist.dz/en/PresentationRevue/905>.
- To submit articles for publication, authors should click the 'Send Article' icon in the list of options on the left side of the screen, in Word format, using the journal's link: <https://www.asjp.cerist.dz/en/PresentationRevue/905>.
- If authors have an existing account (username/password) to access the platform, they should click on the 'Login' option. If they do not have an account, they must register by clicking on the 'Register' option, allowing them to submit their article and track its progress through the platform.

4- Evaluation of the Article:

4-1. First step: The articles are examined confidentially and undergo a stage of verification to ensure they meet the publishing requirements, adhere to the template adopted, and align with the journal's scope. If the decision is negative, the article is rejected on the platform. The author may resubmit it, taking into account the provided recommendations.

4.2. Second step: If the article is deemed eligible (prepared according to the Review template, complies with publishing requirements, and falls within the journal's scope), it will be sent in an encrypted format to the competent assistant editor, who will then forward it to two reviewers within the ASJP platform network. Note: The editor may also evaluate the article if desired.

4.3. Third step: If the reports submitted by the reviewers are positive and in favor of publication, they will be sent to the author with the identities of the reviewers concealed. The author should then make the necessary amendments, if any, to address form or content-related concerns. If one of the reports is negative, the article will be sent to a third advisor for arbitration and a decision on whether to proceed with publication.

4.4. Fourth step: After receiving the article in its modified form, the editorial board will review it to verify if the author has implemented the required amendments. Subsequently, it will be sent to the auditors for further verification. If it is found that the author has not complied with the required amendments, the article will be returned to the author for revision, with a deadline of 72 hours. Failure to comply will result in rejection. If the article is accepted, the final copy will be forwarded to the journal's secretariat for publication.

5. Send the article:

After the article has been prepared following the Review template, it should be submitted by clicking on the "Submit Article" icon. This action will lead to a form that needs to be filled out, including various details regarding the article and its authors. Once all the necessary information has been provided and the article file has been uploaded onto the platform, it can be found below the information form.

6. Follow-up evaluation of the article across the platform:

6.1. Receipt confirmation: Upon successful submission of the article on the platform, a message will appear on the screen, confirming its receipt.

6.2. Rejection notification: If the article fails to adhere to the Review template and publication requirements, the author will be notified of its rejection.

6.3. Tracking article status: Authors can access their account on the platform to monitor the various stages of their article's progress. By clicking on the "Articles" icon, followed by the "Sent Articles" icon, a table will display all the details of the article.

7. Publishing articles on the platform: Once an article has been accepted for publication, the author will receive an electronic message with instructions to access their account on the platform. The author is then required to include the approved references within the article, following the guidelines specified by ASJP. Failure to include the references will result in the non-publication of the accepted article.
